Hereby take note that South Ayrshire Council Asset Management Service, Newton House, 30 Green St Lane, Ayr KA8 8BH has lodged a Petition at Ayr Sheriff Court in terms of Section 75(2) of the Local Government (Scotland) Act 1973, for permission to alienate an area of Ayr Common Good amenity ground, by proposing to lease (with option to buy) 148 square metres or thereby of ground adjoining the western (seaward) side of Pirate Pete's, Pavilion Rd, Ayr to Dion Property Ltd (Pirate Pete's).
