

SOUTH AYRSHIRE TOWN CENTRE AND RETAIL LOCAL DEVELOPMENT PLAN (LDP): MAIN ISSUES REPORT (MIR) CONSULTATION

The Council approved its MIR on 2nd September 2015, for public consultation. The MIR is intended to consult on options for future planning policies covering retail developments and town centres. It also focuses on the role and function of Ayr town centre.

In accordance with the Town and Country Planning (Development Planning) (Scotland) Regulations 2008, a 6-week consultation on the MIR will open on 7th September and close on 16th October 2015.
