

**LAND REFORM (SCOTLAND) ACT 2003  
NOTICE OF ORDER TO EXEMPT LAND FROM  
ACCESS RIGHTS**

Under Section 11(9) of the Land Reform (Scotland) Act 2003 (the "Act"), the Council gives notice that, on 8 July 2012, the Scottish Ministers, acting under Section 11(7) of the Act, confirmed THE SOUTH AYRSHIRE COUNCIL (TURNBERRY GOLF COURSE, RICOH WOMEN'S BRITISH OPEN GOLF CHAMPIONSHIP) EXEMPTING LAND FROM ACCESS RIGHTS ORDER 2015 (the "Order"), proposed by the Council under Section 11(1) of the Act.

The effect of the Order is to exempt the area of land comprising Turnberry Golf Course, including the access road to Turnberry Lighthouse, outlined in red on the plan annexed to the Order, from the access rights which would otherwise be exercisable in respect of that land by virtue of Part 1 of the Act.

The purpose for which the Order is made is to enable the 2015 RICOH Women's British Open Golf Championship to be held, with the land being exempted temporarily from access rights: (1) in the interests of the health and safety of the public and construction workers, as well as the security of materials and supplies, during the installation and dismantling of temporary structures and facilities on the Course, before and after the Championship; (2) in the interests of the safety and security of players and the safety of the public, during the Championship itself; and (3) to permit an entrance fee to be levied on spectators during the Championship.

The Order is effective from 00.00 hours on Monday **13 July 2015** and will expire at 23:59 hours on Monday **10 August 2015**.

Certified copies of the Order, and accompanying plan showing the area of land exempted temporarily from access rights, may be inspected, free of charge, at the office of the Head of Enterprise, Development and Leisure, Burns House, Burns Statue Square, Ayr, from 0845-1645 (Mon-Thu) & 0845-1600 (Fri), during the period from the date of publication of this notice until the date of expiry of the Order.
