**1.       Purpose**

- 1.1       The purpose of this report is to make alterations to the lists of Panels, Outside Bodies, Working Groups and COSLA.

**2.       Recommendation**

**2.1       It is recommended that the Council:**

- 2.1.1       approves the amendments outlined at 4.1;**
- 2.1.2       requests that the Labour Group Leader confirms the appointment of the Chair to the Service and Partnerships Performance Panel outlined in 4.2;**
- 2.1.3       requests that the Independents confirm the appointments to the Service and Partnerships Performance Panel and to the Audit and Governance Panel outlined in 4.3;**
- 2.1.4       requests that the Conservative Group Leader confirms the appointment to the Chief Officers' Appointments/ Appraisal Panel outlined in 4.4.; and**
- 2.1.5       agrees the changes to the representatives appointed to the Outside Bodies, Working Groups and COSLA outlined in [Appendix 1](#).**

**3.       Background**

**3.1       At a special meeting on 20 May 2025, the Council:**

- 3.1.1       nominated and appointed Councillor Iain Campbell as Provost and Councillor Brian Connolly as Leader of the Council; and**
- 3.1.2       agreed that a report seeking approval of consequential vacancies on Panels, Outside Bodies, Working Groups and COSLA be considered at a special meeting of the Council on 23 May 2025.**

3.2 In terms of para 11.1 of the Council's Scheme of Delegation, amendment of the membership of Cabinet and other Panels, Committees and Sub-Committees is reserved to Council.

3.3 In terms of para 11.2 of the Council's Scheme of Delegation, the selection and de-selection of Councillors and officers to serve on and/ or to represent the Council on Joint Committees, Joint Boards and other external bodies and organisations is reserved to Council.

4.1 Members of the Administration have requested that the Council notes and approves the following changes:

##### **4.1.1 *Cabinet***

- Councillor Chris Cullen replaces Councillor Bob Pollock as the Portfolio Holder for Economic Development;
- Councillor Mark Dixon replaces Councillor Brian Connolly as the Portfolio Holder for Sport and Leisure; and
- Councillor Brian Connolly, as Leader of the Council, becomes the Portfolio Holder for Corporate and Strategic Portfolio;

##### **4.1.2 *Service and Performance and Partnerships Panel***

- the resignation of Councillor Chris Cullen as Chair, and that the Chair of the Service and Partnerships Performance Panel be a member of the Labour Group; and
- the resignation of Councillor Mark Dixon from the Service and Partnerships Performance Panel.

##### **4.1.3 *Audit and Governance Panel***

- the resignation of Councillor Chris Cullen from the Audit and Governance Panel.

##### **4.1.4 *Chief Officers' Appointments and / Appraisal Panel***

- Councillors Brian Connolly and Alec Clark, as Leader and Depute Leader of the Council, become members of the Chief Officers' Appointments/ Appraisal Panel.
