## **LOCATION**

Ayr is the administrative and principal retail centre for Ayrshire with a population of around 48,000 persons and a catchment population in excess of 180,000 persons. The town is situated approximately 40 miles south-west of Glasgow City Centre.

The premises are located at 21 Carrick Street, Ayr, lying to the west of the town's High Street.

## **DESCRIPTION**

The premises comprise a ground floor retail unit with a toilet and kitchen to the rear. Ancillary storage accommodation is available at first floor level.

## **GROSS INTERNAL AREA**

The premises extends to approximately 25.8 sq m (277.71 sq ft).

## **RATEABLE VALUE**

The rateable value is currently £3,900. The property may benefit from 100% rates relief under the Small Business Bonus Scheme for qualifying occupiers.

The property was formerly used as a jeweller, but it may be suitable for various alternative retail or office uses although planning consent may be required for any change of use.

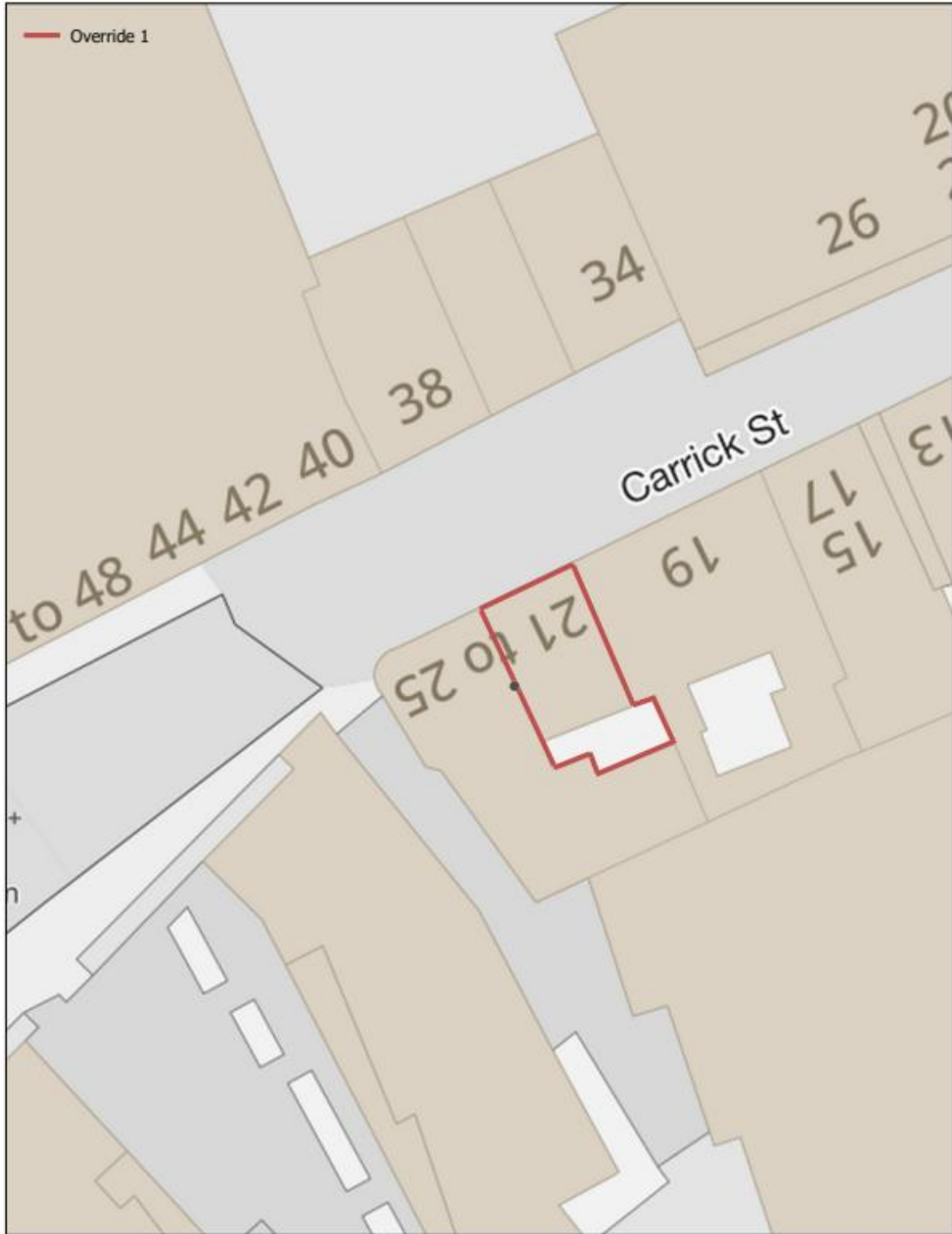
