## **LOCATION**

Symington is an attractive village with a population of approximately 1,200, situated around 5 miles north of Prestwick in South Ayrshire. The village is popular with commuters due to its location next to the A77 trunk road which offers good links to Glasgow, approximately 25 miles to the north.

There is a range of local services including a primary school and shops and the village also benefits from a regular bus service to both Ayr and Glasgow.

## **DESCRIPTION**

The newly constructed premises comprises of one multi-purpose space, changing areas (including showering facilities) and toilets.

## **GROSS INTERNAL AREA**

The premises extends to approximately 155 sq m (1668.4 sq ft).

The building has mains supplies of water and electricity.

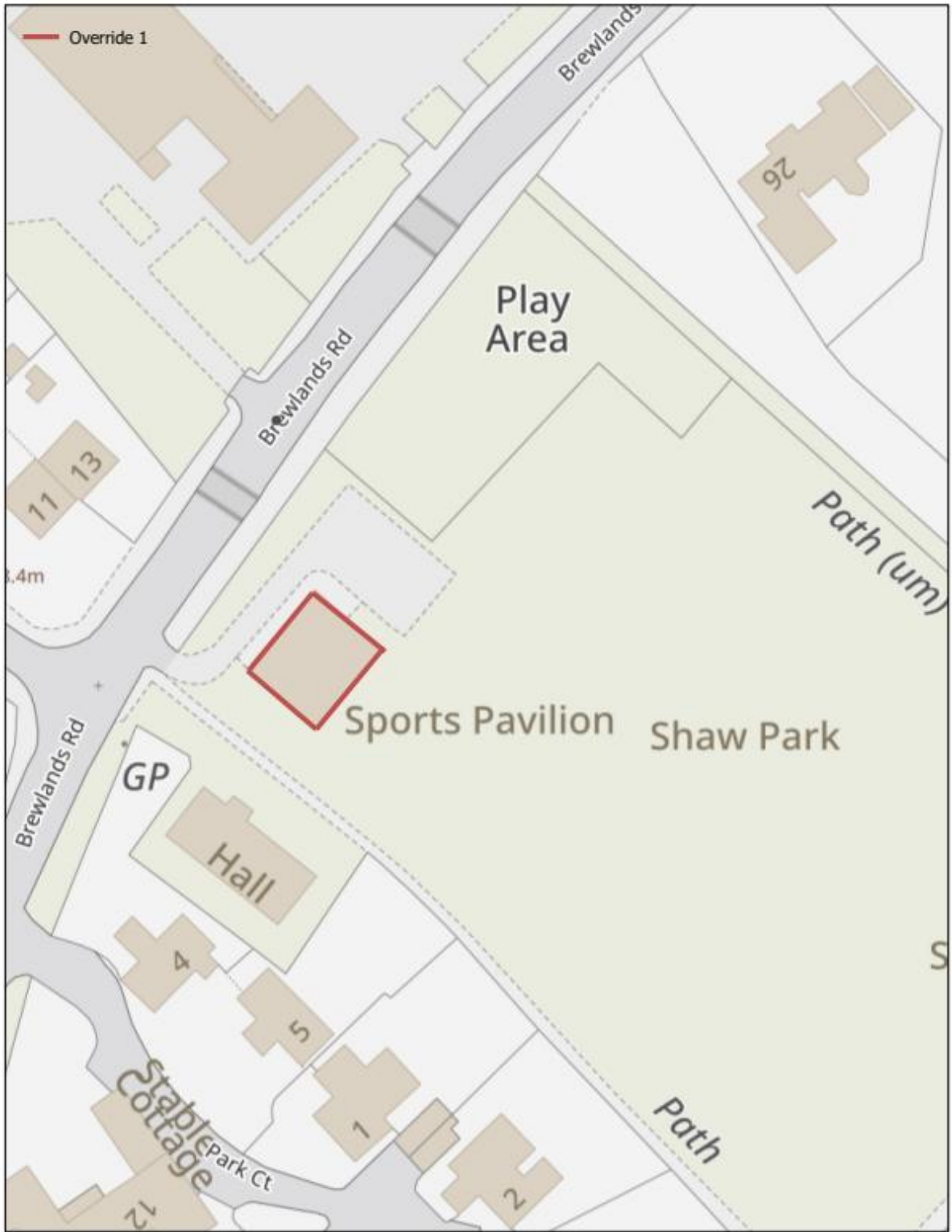
