INTRODUCTION

The role and reach of Community Safety Partnerships in promoting safer communities has widened over the last few years.

Community Safety partners are part of the more complex community planning arena with a focus on shifting to prevention, and working in partnership to support community planning outcomes.

The Community Safety Partnership's current strategic approach focusses on ensuring joined up action around community safety partnership priorities. The partnership brings together relevant agencies and, using a targeted approach, ensures effective information sharing and agreement on areas for joint action. The Community Safety Partnership strategic plan, sets out our shared vision for improving community safety outcomes across South Ayrshire, which acknowledging the added value which joint working brings, and a commitment to working with communities to improve outcomes at a local level.

OUR SHARED VISION

That people in South Ayrshire live in communities that are inclusive, empowered, resilient and safe



- Reduce the level of violence and antisocial behaviour in our communities;
- · Reduce the number of serious accidents at home and on our roads;
- Increase positive community engagement to tackle ASB and community safety issues within communities; and
- Work with partners to deliver CPP priorities.

AREA PROFILE


By 2043, the South Ayrshire population is projected to be 105,191 - a decrease of 6.5% compared to the population in 2018. The population of Scotland as a whole is projected to increase by 2.5%.

The projected change in South Ayrshire is not evenly spread across the different age groups. The number of children aged 0-15 years is projected to decrease by 17% and our working age population by 14%. The pensionable age population is, however,

projected to increase by 17% by 2043. More dramatically, the South Ayrshire population aged 75+ is projected to increase by 65% by 2043.

These anticipated changes to the population will have considerable consequences for the Council as it strives to ensure social, educational, housing and community services continue to meet the needs of the community.

The Community Safety outcome is outcome 11: "We live in communities that are inclusive, empowered, resilient and safe" This incorporates the previous Safer and Stronger outcome, while acknowledging that in order to deliver Community Safety services effectively we need to consider what makes a safer community, which includes elements such as community engagement and cohesion, social relationships and community empowerment as well as issues of poverty, health and education.

The Place Standard / Principle

All those responsible for providing services and looking after assets in a place need to work and plan together, and with local communities, to improve the lives of people, support inclusive and sustainable economic growth and create more successful places.

Focus on a small number of real priority areas which are levers that will make a big difference. In South Ayrshire there are 2 main priority areas:-

- Supporting older people to live in good health



HEALTH AND WELLBEING




- Life expectancy male is 77.3 compared with 77.1 nationally (2016-2018)
- Life expectancy female is 81.3 compared with 81.1 nationally (2016 to 2018)
- In 2016, there were 14 suicides in South Ayrshire
- Suicide deaths were around three times more likely among those living in the most deprived areas than among those in the least deprived areas.
- The South Ayrshire rate of alcohol related hospital stays per 100,000 rose from 776.3 in 2016/17 to 831.2 in 2017/18 compared with a reduction across Scotland of 737.8 to 718.5.
- The South Ayrshire rate of drug related hospital stays per 100,000 rose from 300.21 in 2016/17 to 316.6 in 2017/18. Scotland also saw a rise from 220.9 to 236.5.
- The number of drug deaths per year has risen across Scotland. South Ayrshire figures rose from 12 in 2017 to 15 in 2018.

DEPRIVATION



- 7 datazones (4.7% of the population) are in 5% of the most deprived areas in Scotland
- 20 datazones (12.1% of the population) are in 15% most deprived areas in Scotland
- 20% of households are fuel poor compared with 25% nationally
- 4% of working age people claiming one or more benefits compared with 3.3% nationally
- 36.1% of children living in households that experience both low income and material deprivation compared with 20.7% nationally (2014-17 figures)
- 24.4% children living in poverty (after household costs) 2017/18 (10th highest nationally)

REDUCING VIOLENCE AND ANTISOCIAL BEHAVIOUR IN OUR COMMUNITIES



Scottish Household Survey

87% or residents in South Ayrshire feel very/fairly safe when walking alone in their neighbourhood after dark (2019 figures). For Scotland this figure is 83%.

Handling an offensive weapon which was not used in other criminal activity has increased by 18% in South Ayrshire which is the same as the Scotland rate. 40% of offences involving an offensive weapon were used in criminal activity in South Ayrshire during 2018/19.

In 2018/19, 25 inputs were delivered to 450 young people in relation to No Knives Better Lives toolkit


The annual trend shows that violent crime in South Ayrshire has fallen since 2010-11



In last 3 years, almost 100,000 people have accessed the SafeAyr taxi rank

Taxi marshals have dealt with with 50 incidents and now wear body cameras to record any issues

Street Pastors have helped over 400 people who were in need of attention – including charging phones, supporting vulnerable individuals, and assistance to get a taxi. They have given out 861 items including flip flops, lollipops, blankets and water.






In 2018/19 South Ayrshire had the 14th highest rate of violent crime in Scotland but is below the Scottish rate.

REDUCING VIOLENCE AND ANTISOCIAL BEHAVIOUR IN OUR COMMUNITIES



Group 6 disorder crimes which include minor assaults, breach of the peace, drinking in public and urinating have been falling steadily since 2013/14. There has been a 32% reduction over this time period.





The Community Justice JAG have agreed to promote and facilitate the PING liberation survey which look at challenges people are facing around time of release

The group also produced a 20 minute educational film – 'The Journey' - which details what happens when we fall foul of the law, its processes, procedures and the reality of being in Police custody.

COMMUNITY SAFETY Workers have carried out over 1000 general patrols and 400 targeted patrols over the last three years

SAFER SHORES

270 people surveyed over last three years and 90% Said they felt safe (Ayr esplanade)



Community Safety Workers have reported over 1200 flytipping incidents since 2016/17

Over the last 3 years, community safety have dealt with over 80 antisocial behaviour complaints logged on the council reporting system.

The majority of these complaints were in relation to youth disorder including graffiti/ vandalism, drinking in public, loitering, throwing items and general nuisance.

Dver 500 staff have attended awareness raising sessions on doorstep crime over last couple of years.

Over 100 school litter patrols and 200 fixed penalty patrols have been carried out by Community Support Workers over the last 3 years.




A high percentage of antisocial behaviour complaints dealt with by housing (83%) were opened and resolved in 2018/19. Most of the cases were in relation to noise / neighbour disputes




REDUCING SERIOUS ACCIDENTS IN OUR HOMES AND ON OUR ROADS

The number of people killed or seriously injured in a road collision in South Ayrshire has been increasing since 2012/13.



Based on a 3-year rolling total, the number of road deaths in Ayrshire killing 16-25 year olds between 2016-18 was 5 which is a 80% reduction from 2014-16.


Reckless Driving Wrecks Lives has been seen by almost 5000 students and young people in 24 schools or colleges over the last three years.



Over 400 referrals received for Fire Safety project and 158 items issued over last 3 years.



The number of fire related fatalities and casualties in south Ayrshire has fallen by 5% over the last 3 years up to 2017/18. In Scotland there has been a reduction of 13%



South Ayrshire is the 4th highest ranking local authority when comparing the 3-year average rate (2014-17) for emergency admissions due to an unintentional injury in the 65+ age group. Falls accounted for 86% of all emergency admissions during this period




Large number of older people attending Invigor8 and Health & Rehabilitation classes each year.

'Safe at Home' booklet produced and is being distributed widely by housing, care teams, VASA and sheltered housing.

INCREASE POSITIVE COMMUNITY ENGAGEMENT TO ADDRESS ANTISOCIAL BEHAVIOUR AND COMMUNITY SAFETY ISSUES IN OUR COMMUNITIES

Deliberate secondary fires have been increasing steadily in South Ayrshire since 2015/16.





In 2018/19, the fire service attended 4 observed bonfires



which equates to a saving of £61,070 when compared to 2008

Community Safety have removed 45 instances of graffiti since 2016/17

Group 4 crimes which cover fireraising, vandalism and malicious mischief has fallen by 19% since 2015/16 compared to 11% reduction for Scotland.



There have been intergenerational projects throughout South Ayrshire over the last 3 years including work with community garden, music projects, IT initiative in sheltered housing, and school participation in the annual quiz

The TAYP programme is delivered by South Ayrshire Community Safety team and aims to engage young people who are involved in, or on the periphery of antisocial behaviour/crime in the community, which is often linked to alcohol use. the last 3 years. Community Safety has delivered almost 300 diversionary

Youth incidents reported to

almost 300 diversionary activities to 7,600 young people over the last 3 years (2017/18-2019/20).

This includes targeted work as well as school inputs and streetsport sessions.

"Read between the Lines" is a drama aimed to reduce the stigma surrounding mental health and suicide by encouraging people to acknowledge that talking openly can make a

positive difference and maybe save a life.

The drama was delivered to S5/S6 pupils in all secondary schools in South Ayrshire in 2019/20




Since 2016/17, there have been 70 environmental initiatives carried out involving 1089 young people

Over 120 community members have also been involved in initiatives.

UNDERPINNING THEMES

Prevention, early intervention and problem solving have been a consistent, core part of the Community Safety Partnerships approach to working with partners and local communities to address community safety and antisocial behaviour issues.


There are additional elements of emerging and underpinning themes which need to be considered when taking forward joint action by community safety partners.



ADVERSE CHILDHOOD EXPERIENCES (ACE'S) /TRAUMA INFORMED APPROACH

The Sottish Government has committed to preventing ACE's, building resilience and reducing the negative impact of ACE's on communities. Links have been identified both nationally and internationally between higher experience of ACE's and community safety issues such as offending, violence, substance misuse and domestic abuse.

The Community Safety partnership held a seminar to explore these issues further, and agreed a commitment to a greater awareness of Adverse Childhood Experiences, and taking a trauma informed approach to all joint working. This will include working with the wider Strategic Delivery Groups within Community Planning, to ensure a joined-up, consistent approach to partnership working.



IMPACT OF ALCOHOL AND DRUGS

The CSP has always had strong links with the Alcohol and Drug Partnership in South Ayrshire and the links between substance misuse and community safety are evident in a number of areas, from alcohol related crime, injury prevention, youth issues and domestic abuse. Joint working around these issues has formed the basis of much of our community safety work with local communities.



The CSP will continue to work in partnership with the ADP to explore opportunities for joint action, and continue to take prevention and early intervention.

REDUCING POVERTY

Wider structural and social issues can have a negative impact on feelings of safety in communities. South Ayrshire Community Planning Partnership have a commitment to 'closing the poverty-related outcomes gap' as one of the high level strategic themes within the Local Outcome Improvement Plan South Ayrshire Local Outcomes Improvement Plan



The Community Safety partnership have therefore committed to embedding poverty related issues as an underlying theme to the strategic plan ensuring that the impact of poverty in local communities is considered when developing joint action in line with our key priorities.

MEASURING PROGRESS

In order to measure progress in achieving our community safety outcomes we will use a range of information, including data from partners, feedback from people in local communities, local place plans, evaluation of initiatives and outcome measures within our performance management system.

CSP JOINT ACTION GROUPS

Partnership working to achieve the agreed priorities of the CSP is taken forward through Joint Action Groups. These groups are supported by lead officers from Community Safety team, and usually chaired by one of CSP partners. There are four JAG's involving a range of partner agencies, covering the following key issues: Reducing Violence, Fire and Road Safety, Inter-generational Issues and Safer Places.

The remit of the Joint Action Groups is as follows:-

- To work together with community safety partners to take an early intervention approach to address community safety issues in South Ayrshire, developing partnerships, communities and learning opportunities,
- To progress projects and joint initiatives within agreed budgets and resources,
- To identify issues of concern and provide exception reports to the Community Safety
 Partnership



• To ensure initiatives are fully evaluated.

ACTION PLANS

Joint Action Groups will develop, review and update action plans annually. Action Plans will be reviewed and agreed by the Community Safety Partnership.

The Joint Action plans attached have been developed by each of the Joint Action Groups, and reflect joint work which is able to be progressed within current Covid restrictions. As restrictions are eased, and more partner services are able to be delivered locally, the plans will be reviewed and updated to reflect changing circumstances.
