LOCATION

Ayr is the administrative and principal retail centre for Ayrshire with a population of around 48,000 persons and a catchment population in excess of 180,000 persons. The town is situated approximately 40 miles south-west of Glasgow City Centre.

The subjects benefit from a prominent frontage at the northern end of Sandgate and the bottom of the High Street.

DESCRIPTION

Following severe fire damage, the unit has been comprehensively reconstructed to a high standard of finish in late 2025/early 2026.

The subjects comprise a ground floor retail unit with a glazed frontage and entrance to High Street. Accommodation comprises a main shop area and back staff/toilet area.

NET INTERNAL AREA

The subjects extend to approximately 37.5 sq m (403.64 sq ft).



SERVICES

Mains drainage, water and electricity are available within the property.

RATEABLE VALUE

The Rateable Value has remained as “premises Under Reconstruction” at a Nil value. The rateable value will be assessed by the assessors in due course. The tenant will be responsible for the payment of rates and water rates levied; however, the tenant may be eligible for 100% rates relief under the Small Business Bonus Scheme.

The EPC rating of this property is TBC.

PLANNING

The property may be suitable for various uses including as a shop or office but planning consent may be required for a change of use.

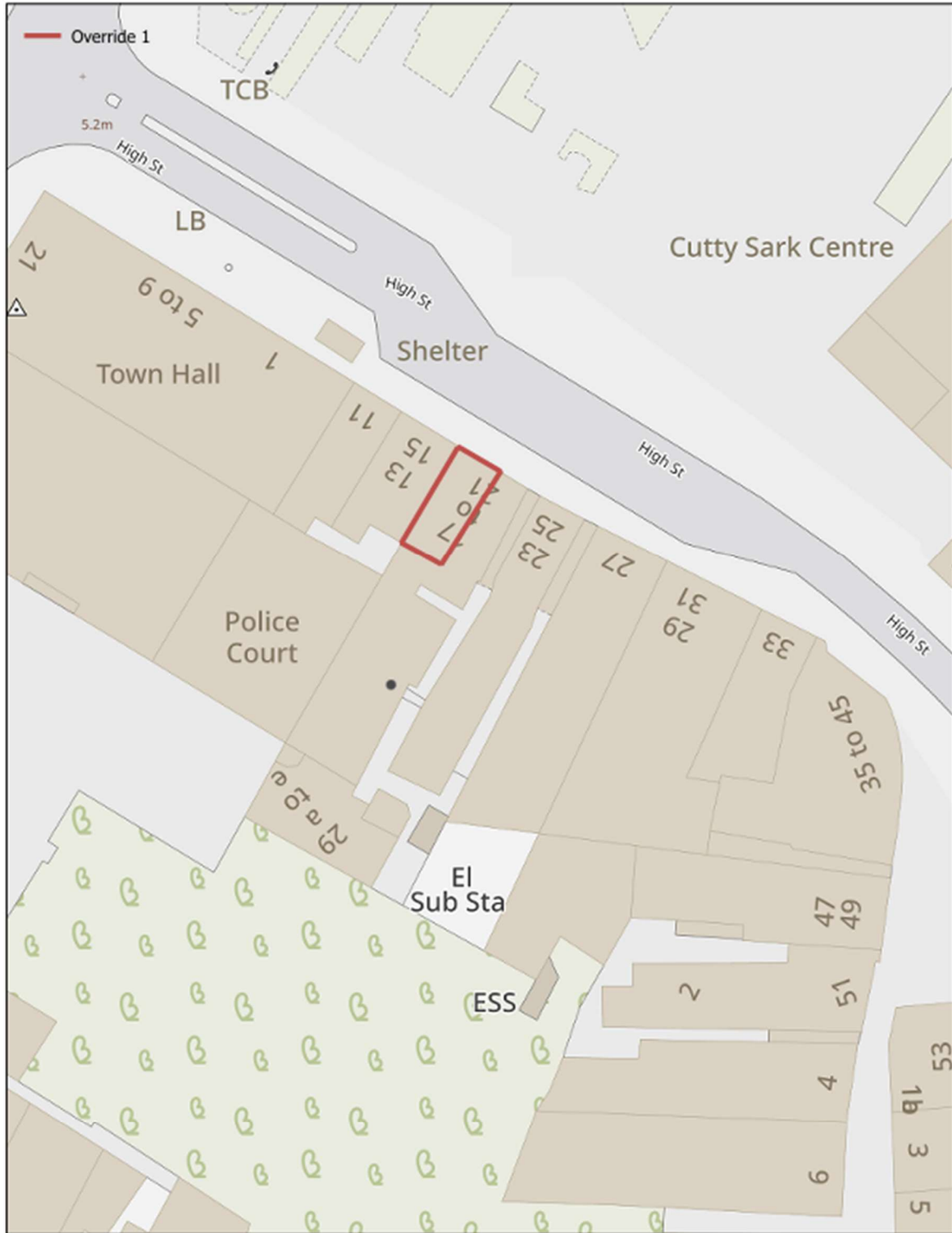
