SOUTH AYRSHIRE LICENSING BOARD.

Minutes of a meeting held remotely on 13 January 2022 at 10.00 a.m.

Opening Remarks

The Chair welcomed everyone to the meeting and outlined the procedures for conducting this meeting and advised that this meeting would be broadcast live.

1. <u>Declarations of Interest</u>

There were no declarations of interest by Members of the Board in terms of the Councillors' Code of Conduct.

2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Thursday, 10 February 2022 at 10.00 a.m.

3. Minutes of Previous Meeting

The Minutes of the Meeting of South Ayrshire Licensing Board of 18 November 2021 (issued) were submitted.

<u>Decided</u>: to approve the Minutes of the previous meeting.

4. Update by Licensing Standards Officer

The Licensing Standards Officer advised:

- (1) that; additional guidance and regulations for the hospitality trade were introduced just before Christmas and these 'changes' had a considerable impact on the liquor licensed trade. One of the main challenges posed by the new guidance was the lack of clarity and information available and the late hour that this was resolved. This meant that there was a large number of cancellations, many last minute which left the trade, and those that supply them, with the issue of what to do with food and drink and how to pay for the losses;
- (2) there had been the promise to the liquor licence trade of a payment from the Government to compensate for the losses as a result of the regulations and guidance which would be either £4500 or £6800 depending on the rateable value of the premises. Premises had been invited to apply for this from this week in South Ayrshire and the payment was expected this month, however the general view of the licensed trade in South Ayrshire was that this would in no way represent what revenue could have been made over the festive period, regardless of whether it was a food led premises or mainly wet sales. For food led

premises the restriction on the number of households and the advice against Christmas Parties had the biggest impact and for the smaller and wet sales venues it had been the 'table service only' and 'only drinking whilst seated' that had prevented many from trading viably:

- (3) In addition to this came the announcement that 'Nightclubs' must close in Scotland. As Members would be aware, the Licensing (Scotland) Act 2005 removed the categories of licence and as a result there were no venues licensed as a 'Nightclub' in South Ayrshire, instead they simply had a Premises Licence. This once again led to some confusion as there were smaller capacity venues or venues who opened during the day that also had core hours which extended as late as 2.30am. However, throughout the pandemic, premises had required to provide various Covid Risk Assessments and a Covid Compliance Plan to Environmental Health which would identify them as a particular 'type' of premises. Once the Covid pandemic and associated regulations and guidelines were finished, the 'category' of 'Nightclub' may be the subject of future debate, certainly among operators in South Ayrshire who had already indicated they would be looking for clarification:
- (4) In previous years (pre-pandemic) the month of January had always been a quiet one for the liquor licensed trade (both on and off). However, 2022 in particular, many operators were choosing not to open and instead were using the time to offer staff holidays, catch up on paperwork and take the opportunity to clean and refresh the premises. With the wider issue of so many people currently isolating and/or staying away from anything other than essential outings, the traditional wet sales premises in particular had noticed it to be much quieter than expected; and
- (5) Staff training was an issue that she hoped to address further this year as many new employees had entered the hospitality trade over the past two years. Monthly courses were available locally for the Scottish Certificate for Personal Licence holders, and she hoped to deliver the 2-hour staff training project again later this year once guidelines allowed.

The Board, having thanked the Licensing Standards Officer for her update,

Decided: to note the report.
