## REPORT BY THE CLERK TO THE LICENSING BOARD OF 10 FEBRUARY 2022

### **Subject: Revocation of Personal Licences**

### 1. Purpose

To advise members on the revocations of personal licences.

#### 2. Recommendation

To note the terms of the report

### 3. Background

The Licensing (Scotland) Act 2005 introduced personal licences. It is a condition of the personal licence that (a) the applicant undertakes refresher training within five years of the date of issue of the licence and (b) no later than 3 months after the expiry of five years from the date of issue produces evidence of the training to the Board. Failure to complete either part of the process means that the Board must revoke the personal licence. (Licensing (Scotland) Act 2005 section 87(3)

#### 4. Current Position

A number of licence holders were due to have completed their refresher training before the coronavirus pandemic struck in March 2020 and under normal circumstances their licences would have been revoked three months after the expiry of the five-year period from the date of issue of their licence. E.g.- if a licence was granted on 30 January 2015, refresher training should have been completed by 30 January 2020 and a certificate forwarded to the Board no later than 30 April 2020. Since the licence holders listed on Appendices 1 have not complied with the refresher training requirements, their licences have now been revoked.
