### SOUTH AYRSHIRE LICENSING BOARD.

Minutes of a meeting held remotely on 19 April 2022 at 10.00 a.m.

### **Opening Remarks**

The Chair welcomed everyone to the meeting and outlined the procedures for conducting this meeting and advised that this meeting would be broadcast live.

### 1. Declarations of Interest

There were no declarations of interest by Members of the Board in terms of the Councillors' Code of Conduct.

# 2. Date of Next Board Meeting

The Chair advised that the next Board meeting would be held on Wednesday 20 April 2022 at 10.00 a.m.

## 3. Minutes of Previous Meeting

The Minutes of the Meeting of South Ayrshire Licensing Board of 10 March 2022 (issued) were submitted. There was a question around the timing which Councillor A. Campbell left the meeting on 10 March 2022, and it was agreed that the recording would be listened to and amended as appropriate for final approval.

## 4. Update by Licensing Standards Officer

The Licensing Standards Officer advised:

- 1) That over the past month there had been an increase in the number of Occasional Licence applications received. The applications range from Weddings and family events to gala days and concerts.
- 2) That staff training remained an issue and now that more course providers are running SCPLH courses more regularly, she continues to remind Premises Managers that South Ayrshire Board's policy 'expects' a personal licence holder to be on the premises at all times.
- 3) That the minimum mandatory training of 2hrs is lacking or inadequate on a number of premises and now that regular routine checks are taking place again, she anticipates a number of premises will require to tackle this issue as a matter of urgency., The Coronavirus legislation brought in a relaxation of timings for training for personal licence holders, however this did not relate to the overall requirement for all staff to be trained and she remained concerned about the number of staff who have entered the hospitality trade over the past two years and have not received the required training.

- 4) There are special provisions for Members' Clubs in the Licensing (Scotland) Act 2005, which include no need for a premises manager and a lower annual fee, however this type of premises also has specific requirements such as they should only be open to members and correctly signed-in guests, unless an occasional licence is in place. This means that members clubs should not be advertising 'open to all' and must operate in accordance with their constitution. The Licensing Standards Officer said that she had been made aware of a number of members clubs in South Ayrshire who have changed the way in which they operate after opening post-covid and will therefore require to vary their licence accordingly. She is currently in the process of contacting all clubs to request up to date information and to arrange a visit and will report on this piece of work to a future meeting of South Ayrshire Licensing Board.
- 5) The Scottish Grand National festival was earlier than usual this year and took place at Ayr Racecourse on Friday 1st and Saturday 2nd April 2022. In preparation for the event she met with the Premises Manager of the Racecourse and attended the meeting with the representatives from the agencies who provide licensed staff on race days to re-enforce the need for documented training, challenge 25 and refusal of sales. She attended the Racecourse on Saturday 2<sup>nd</sup> April to complete checks on the bars and the staff and to observe the general running of the event which also benefitted from an Occasional Licence. As this was the first large scale event in South Avrshire since the lockdowns it undoubtedly attracted a number of patrons who were very keen to be out socialising again and who had perhaps not been out for some time. It was very disappointing to note the high levels of drunkenness and the resulting behaviour of some individuals leading to complaints from local residents and members of the public and has raised some issues that have been brought to the attention of the Racecourse and will be dealt with prior to the next large-scale race meeting the Ayr Gold Cup. She was also concerned to note that many of the staff who were brought in via agencies for race day appeared overwhelmed by the queues and volumes of customers at the various bars and as a result their ID checks and judgements may have been forgotten in many circumstances. On the day, she met with the Premises Manager who acknowledged the challenges he and his staff faced and further discussions have been arranged for the near future.

The Board, having thanked the Licensing Standards Officer for her update,

<u>Decided</u>: to note the report and requested that a further report regarding the Scottish Grand National Festival be brought to the June Board

<u>Decided</u>: to grant the above application subject to the variation not coming into effect until such time as the completion certificate for the alterations has been granted and subject to the following conditions:-

- 1. The Terminal hour for the outside drinking area to remain at 22:00 p.m.
- 2. The external area must be appropriately stewarded as necessary whenever in use, on a risk assessed basis.

- 3. The premises must operate a policy in relation to the safe and controlled access, egress and dispersal of customers from the external area.
- 4. The premises must observe and maintain a noise impact assessment and noise management plan in respect of the use of the external area.

Further, the applicant gave an undertaking that a temporary barrier will be deployed to restrict access to the lane at the rear. Should a vehicle require access, the barrier can be removed temporarily. There will be a staff presence to monitor this.
