LOCATION

Ayr is the administrative and principal retail centre for Ayrshire with a population of around 48,000 persons and a catchment population in excess of 180,000 persons. The town is situated approximately 40 miles south-west of Glasgow City Centre.

The subjects are located within the town's North Harbour area to the north of the town centre. This area is dominated by a variety of commercial and light industrial uses.

DESCRIPTION

The subjects comprise a modern workshop unit of brick and block construction with a mono-pitch profiled metal sheet roof.

ACCOMMODATION

The subjects extend to a size of 80 sq m (860 sq ft) comprising a workshop, office, office/store, kitchen area, lobby and toilet (disabled).

Parking is available in the common area to the front of the building.

SERVICES

The building has mains supplies of water and electricity.

RATEABLE VALUE

The rateable value is currently £3,950. The tenant will be responsible for the payment of rates and water rates levied.
